Hospital reserves the right to provide the medical report in our prescribed format or on your form provided. Payment of standard charge of HK\$895 per department per report requested. (This amount is non-refundable even if the request is withdrawn subsequently. Special charges up to HK\$3,580 may be charged for reports requiring special professional input. Applicants will be informed of the extra charges before the report is processed.) Normally, it will take four to six weeks to complete the procedure. II. Copy of Medical Records

For supplying a copy of the medical records under request, processing fee and reproduction charges are payable: The processing charge is HK\$76 per request, inclusive of reproduction charge for not more than 10 pages and

After initial processing, we will inform requester the amount of photocopying or duplicating charge payable. The copy data can be collected after payment of such charge.

The reproduction charges for the 11th page and onward of paper based records is HK\$1 per page.

The reproduction charges for ECG, EEG or X-ray Film (C.T. Scan/M.R.I. etc.) is HK\$230 per modality per disc / per film.

III. Remarks

Applicant should complete the request form and submit together with the following documents:

- 1. Identification Documents of the Deceased and the Applicant.
- 2. Deceased's Death Certificate.
- 3. Documentary evidence to support the relationship between the Deceased and the Applicant. in person and submit together with the above documents to "Medical Report Unit of The Duchess of Kent Children's Hospital at Sandy Bay" or provide the completed request form, cross cheque and true copy of the above documents to us by mail to "1/F, Block A, The Duchess of Kent Children's Hospital at Sandy Bay, 12 Sandy Bay Road, Hong Kong". Crossed cheque should be made payable to "HOSPITAL AUTHORITY". All copies of Identification Documents will be used solely for the purpose of this request. They will be destroyed after the completion of this procedure.
